Your input, suggestions, or recommendations, however, will be very helpful to your representatives, and very welcome by them, as an indication of the collective thinking of Bent Lodge.

With the 138th Annual Communication my tenure as Grand Marshal of the Grand Lodge of New Mexico comes to an end. During the past year I have had the pleasure of visiting and being made welcome at many lodges throughout our state.
